Transport, Traffic and Parking Plan

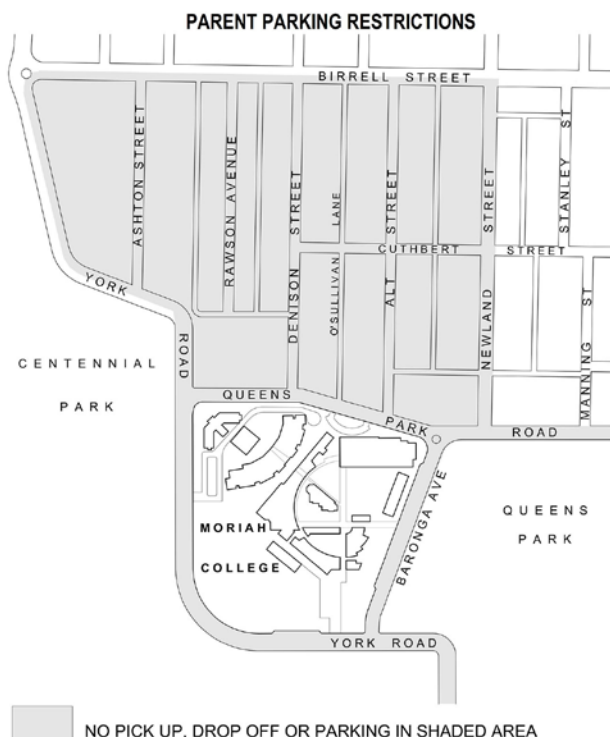
In order for the College to operate safely and efficiently and to minimise disruption to our neighbours, the College has implemented, monitors and enforces a Transport, Traffic and Parking Plan (TTPP) at the Queens Park Campus (QPC). The TTPP has been arrived at after careful consideration and discussions with Waverley Council, the State Transit Authority and representatives of residents living in the Queens Park precinct. The College (including students, parents and staff) is obliged to comply with the TTPP. That compliance by the College (including students, parents and staff) with the TTPP, is monitored by the College, Waverley Council and the local residents.

The College discourages parents/guardians (**parents**) from using private transport to bring children to, and collect children from, the QPC. The QPC is well served by public transport and the College shuttle buses, and the details of these services are set out below. Private transport arrangements should be a last resort and must comply with the established “internal ring road” and “Go with the Flow” systems.

If private transport is used to transport children to and from school, the College encourages parents/guardians to car-pool.

When using the “internal ring road” and “Go with the Flow” systems, it is the College’s policy that parents **MUST** make left turns **only** when entering or leaving the QPC and this must be strictly adhered to.

Parking, stopping, dropping children off or picking children up, is not permitted on the southern side of York Road (opposite the College), or on the eastern side of Baronga Avenue (opposite the College), or on either side of Queens Park Road or on any of the streets adjoining Queens Park Road (Denison Street, O’Sullivan Lane, Alt Street or Newland Street) being the shaded areas in the map below (**Parent Parking Restrictions**).



Parking across driveways and Double Parking is not lawful and you risk fines and demerit points.

1. Public Transport and School Bus Information

Morning and Afternoon School Bus Specials

The College has arrangements with Transdev John Holland for School Bus Specials to deliver and pick up students.

Morning regular bus services

College students also use regular bus services operated by Transdev John Holland to travel from local transport hubs to the QPC.

Afternoon Regular Bus Services

College students also use regular bus services operated by Transdev John Holland to travel from the QPC to local transport hubs and then to various locations in the eastern suburbs.

College Shuttle Bus

The College operates two shuttle bus services that supplement the regular bus services each school day. One to the North Shore and one to Bondi Junction. The College shuttle bus usually loads and unloads in the QPC grounds. No School Special or College shuttle bus drops off or picks up students on Queens Park Rd or on the roads north of the campus.

2. Student Morning Drop Off

Unless special permission has been provided by the College Vice Principal, all students arriving by private transport are required to use the established “internal ring road” and “Go with the Flow” systems.

Any parent with a child in Year K (or with a new student in Year 1 with the permission of the Head of Primary School), who initially does not wish to participate in the go with the flow drop off or pick up procedures must park legally away from the QPC but in accordance with the College’s requirements and the “Parent Parking Restrictions” outlined above and walk their child in or out of the College using an approved Gate (other than the Queens Park Road Gate 2) and proceed to the Primary School.

Parents of injured students and students requiring special consideration will be provided with access to “short term” onsite parking to enable students to be delivered and collected in a safe and controlled manner. Access to this parking is restricted and monitored closely.

Children attending co-curricular activities or band, may use King David Drive 'Go with the Flow' until 7:00am. Parents must observe the Parent Parking Restrictions at all times. There can be no cutting into or out of the “go with the flow” queue. If a driver cannot join the queue then the driver must go around the block and join the queue.

Students on L Plates cannot enter any “go with the flow” queues.

Whilst the queue is moving, a driver cannot stop in the queue other than for the purpose of dropping off or picking up a child.

Remember, just “go with the flow” of traffic, and be patient and considerate.

Children will only be permitted to cross Baronga Avenue or Queens Park Road at the designated pedestrian crossings.

It is illegal to drive or ride a vehicle while using a hand-held mobile phone. This includes talking, sending or receiving text messages, playing games or taking photos while driving. The penalty is a significant fine and demerit points. Parents are also not to use hand-held or hands-free mobile phones whilst using the “Internal Ring Road” nor should they drive with a pet on their lap.

3. Student Afternoon Pick Up

The “Internal Ring Road” and “Go with the Flow” systems will operate and the same rules and procedures as for the morning system set out above will apply with minor variations.

If you arrive at the “go with the flow” and your child is not available to be picked up at the pickup point you cannot stop and wait, but must leave the queue and drive around the block and re-join the “go with the flow” queue.

Remember, just “go with the flow” of traffic, and be patient and considerate.

Parent Parking Restrictions continue to apply for after school pickups.

4. Year 12 Students’ Use of Vehicles

Only Year 12 students may be given permission to drive a vehicle to and from the QPC and may do so only from Term 4 of Year 11, once HSC exams are completed.

All students in Year 12 who wish to drive to and from QPC, **must** obtain, complete and hand in, to the Head of School, a form stating the registration number of the car that they will drive. If at any time a student proposes to use a car with a different registration number, then the Head of School must be notified of the change in registration.

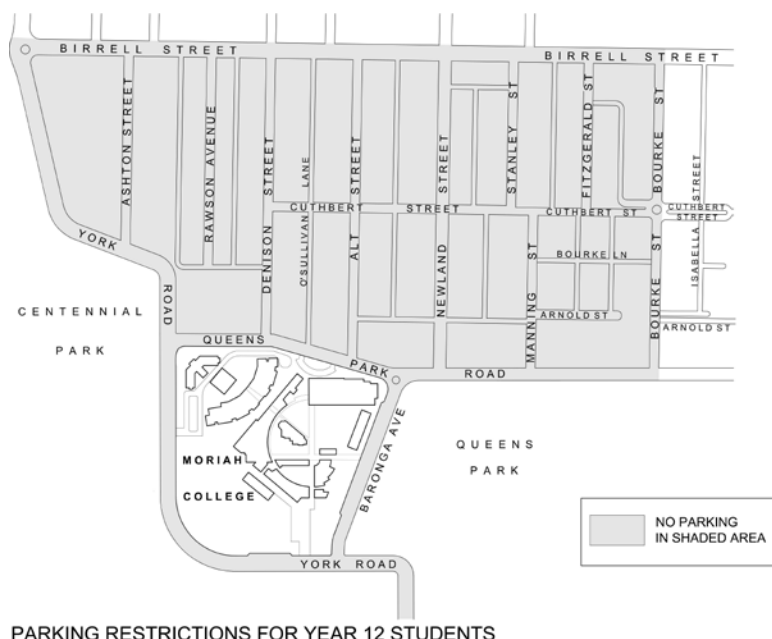
Students must comply with the College’s rules relating to traffic and parking requirements. Failure to do so will put the student’s continued enrolment at risk.

Year 12 students who are bringing siblings to the QPC in their car cannot drop them off other than in accordance with the “go-with-the-flow” and “internal ring road” procedures.

No student is permitted to park a vehicle in the “no parking zone” which is the shaded area marked on the map below. The no parking zone is the area bounded by the northern side of Birrell Street (i.e. both sides), the western side of York Road (i.e. both sides), the eastern side of Bourke Street and Darley Road on the South. In the case of Queens Park Road parking is permitted only on the Southern side (i.e. adjacent to Queens Park) east of a line level with the eastern side of Bourke Street.

Repeat offenders will place in jeopardy their continued enrolment at the College.

Students who are learning to drive must not drive on to the College grounds or join any “go with the flow” queues at any time.



PARKING RESTRICTIONS FOR YEAR 12 STUDENTS

5. ECC/ELC on Queens Park Campus – Drop-Off and Pick-Up

It is a condition of enrolment at the ECC/ELC that parents must comply with these Drop-Off and Pick-Up arrangements. A pro forma regarding drop-off and pick up arrangements will be sent to parents at the beginning of each term. Parents of Early Years' students (ECC/ELC) must park in the designated onsite parking area located on the southern side of the QPC.

Vehicles used to drop-off or pick-up children must display their ECC/ELC parking permit on entry and while parked.

ECC/ELC Parents will not be granted access to the campus through any entry except the designated gate for Early Years students.

Entry to and exit from the designated ECC/ELC parking area is only permissible by left hand turns. Parents are expected to return to their car promptly and depart the car park after their children are in the centre. Cars entering or leaving the designated parking area must be driven in accordance with the directional arrows.

If there is no parking space available when a parent arrives then they must continue to circle inside the campus until a parking space becomes available.

When dropping off or picking up children attending the ECC/ELC, parents must use the designated parking area and must not park anywhere else either on the QPC or in neighbouring streets to the north of the QPC during the operating hours of the College.

ECC/ELC Parents who also have older siblings at the College are permitted and where practical expected, to also drop off and pick up the older siblings when dropping off or picking up their ECC/ELC children from the ECC/ELC designated car park. Parents cannot use the ECC/ELC designated car park except when dropping off or picking up their children from the ECC/ELC.

On Fridays only, parents who are picking up ECC/ELC children or both ECC/ELC and Primary School children, can use a 'Go with the Flow' via the internal road at Gate 4, York Road. Children must be collected during the designated times advertised on eLY. Primary School students with ECC/ELC siblings are walked across to the ELC by a staff member and supervised on the Futsal court. Children are brought to the cars. Parents should not get out of their cars.
